## Harlandale Independent School District Board of Trustees Regular Call Board Meeting December 17, 2018

The Board of Trustees of the Harlandale Independent School District met for a Regular Call Board meeting on Monday, December 17, 2018, Gilbert Elementary School, 931 E. Southcross., San Antonio, Texas 78214. Mr. Juan Mancha, President, called the meeting to order at 6:19 PM.

Roll Call: Mr. Juan Mancha, President; Mr. Esequiel "Zeke" Mendoza, Vice President; Mr. David Abundis, Mr. Ricardo Moreno, Mr. Jesus Tejeda, Members. The Chair declared a quorum present. Ms. Carrillo, Secretary, entered the meeting at 7:55 during closed session.
